Driven by the desire with the actors in the region for the strengthening and multilateral development of economic, social, human resource development, education, trade, scientific, cultural relations etc.

Assured in the belief that firm and friendly relations between the two local government entities will help in the mutual understanding between the District Municipality and the Regional Council.

And bearing in mind that the Cape Winelands District Municipality and Regional Council in Kalmar County constitute two local government entities of independent states, the parties hereby agree to the following:

Clause 1

The strengthening of friendly relations and co-operation that aims to improve knowledge between the citizens of the respective local government entities.

Clause 2

The exchange of experience and knowledge on the following levels of local government administration e.g. institutional transformation and change management.

Clause 3

The development of co-operation on the levels of economic development and tourism. This will focus on encouraging co-operation between the business community, especially medium and small-size businesses of both local government entities.

Clause 4

The actors in the region will also co-operate in field of education that will be agreed upon based on mutual interest. The joint activities must be based on future programmes.
